**Summary and Background Information** 

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund.

Tier 3 - Promising Evidence: Supported by at least one well designed, well implemented correlational study with statistical controls for selection bis is evidence that this strategy improves a student outcome (reading scores, attendance rates), but that research may consist of correlational studies -- stocan show a relationship between the strategy and outcome but cannot show that the improved outcome was the result of the strategy. The studies supp Tier 3 strategies do not have to be based on large, multi-site samples. A strategy that would otherwise be considered Tier 1 or Tier 2, but it does not meaning sample size requirements, is considered Tier 3. No other studies show that this strategy negatively impacts an outcome.

Tier 4 - Demonstrates a Rationale: High-quality research findings or positive evaluation suggests that this will likely improve student outcomes or c relevant outcomes; and there are ongoing efforts to examine the effects of such activity, strategy, or intervention. Glens Falls City School District has engaged school stakeholders and community members throughout the development of the COVID-19 Reopening Plan, including building and district administrators, teachers, support staff members, nurses, buildings and grounds staff, students, parents, Board of Education members, union representatives, and the Warren County Department of Health through surveys, meetings, discussion, and opportunities to submit feedback/ask questions. Specifically, the district's return-to-school surveys garnered quantifiable data and open-ended feedback from more than 1,500 parent/guardian responses, nearly 450 student responses, and more than 200 faculty/staff responses. In addition, GFSD Our school community's sentiments are reflected in our plan, and many of their ideas are incorporated into it. This feedback has served as the basis for our initial CARES, CRSSA, ESSER, and ARP applications.

Glens Falls City School District will continue to engage stakeholders throughout implementation of our plan by providing updates at Board of Education meetings, Curriculum meetings, and Community Forums. Administrators meet with teacher departments/grade levels, social workers, psychologists, and school counselors to discuss students SEL and acadmic needs.

Glens Falls City School District will partner with the Warren County Council For Prevention to conduct a survey to help us determine the social, emotional, and mental health needs of students in the district. This survey will be administered within the school day so that low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students all have school supports in place to complete the survey.

Glens Falls City School District selected evidence-based interventions to address identified student needs based on our Comprehensive Needs Assessment as well as feedback gathered through community members, parents, students, teachers, support staff members, nurses, and district administrators.

Glens Falls City School District intends to coordinate our response to the impacts of lost instructional time with our Title 1 Part A funds by providing additional AIS support for our students in Title 1 buildings/schools and using ARP funds for our non-Title 1 schools within the district. In addition, Glens Falls City School District will provide High Dosage Tutoring to students who need additional instruction to accelerate learning outside the school day. Teacher Assistants will be utilized to provide smaller group instruction within the school day when students are not available after school. Our district has identified learning gaps with phonemic awareness and phonics. A small portion of funds will be used to purchase materials to address these needs.
