**Proposition No. 1**  
**Lease of School Buses**

RESOLVED, that the Board of Education of the Glens Falls City School District is hereby authorized to enter into five year leases for two (2) 65 passenger school buses, at a total amount of lease payments not to exceed \$53,500 per year, and three (3) 30 passenger school buses, at a total amount of lease payments not to exceed \$42,000 per year, and that the total lease payments for the five year leases would be at an amount not to exceed \$477,500, and such annual lease payments shall be paid out of the operating budget of the District in each of the five years.
